

Fork Extensions How to use and view them

By their nature, fork extensions are usually just another item we have in the workshop or yard. They come in handy now and again when bigger lifts are needed. But, once we're done, we put them back into a corner until we need them again – maybe in 12 months' time and sometimes even longer.

With many fork lift dealers and fork lift service companies, the question of fork extensions and compliance with LOLER 98 has just been brushed aside. Recently, however, I have received many enquiries regarding what is and what is not allowed.

Fork extensions are categorised as "Workshop Lifting Equipment or Non- Permanent Forklift Attachments". This means that they are required to have a Thorough Examination under LOLER 98 on a sixmonthly basis. As such, fork extensions need to be inspected, reported and documented on.

Apart from visual checks to ensure they are safe for continued use, you must make certain they are marked up durably and legibly with the following information:

- I. Manufacturer's mark.
- 2. Serial number
- 3. Year of manufacture.
- 4. Rated and load centre distance for the fork extension.
- 5. Required blade cross-section and minimum blade length for the parent fork arm.

The other common question I hear is: "How long can the fork extension be over the parent fork?"

The parent fork must be a minimum of 750mm long.

Over this, the allowable allowance for a fork extension is worked out using the formula:



Here are some examples using that formula:

L = 900mm, L1 = 1500mm therefore 600mm of original fork.

L = 1200mm, L1 = 2000mm therefore 800mm of original fork.

So this actually works out that the fork extension can be 2/3 the length of the parent fork.

Importantly, you do still need to ensure that the extensions are suitable for use, and, in addition to this, that the parent fork and indeed the fork lift truck are capable of lifting that load at the required load centre with the extensions fitted. If you are in any doubt, please contact the fork lift OEM and/or the attachment manufacturer.

If you require any further information, consult the International Standard ISO: I 3284. And, as ever, you may also give me a call.

Fork lift truck users in Jersey can now benefit from assured standards in Thorough Examination, as 4fleet, part of 4group, has become the first Channel Islands company to gain CFTS accreditation.

The law in Jersey

Those familiar with the UK legislation and Health and Safety Executive (HSE) guidance would find Jersey's equivalents very similar. There, the Health and Safety Inspectorate (HSI) has a code of practice and guidance document entitled 'The Safe Use of Rider-operated Lift Trucks' which helps in meeting the requirements of the Health and Safety at Work (Jersey) Law, 1989.



In several places, it refers to the Chains, Ropes and Lifting Gear (Jersey) Regulations, 1980, similar to the UK's LOLER 98 requirements, and specifies the need for 'thorough examination by a competent person'.

Interestingly, where chains form part of the lifting equipment, Jersey's regulations stipulate that they be thoroughly examined every six months.

Mike explains: "On the mainland, chains must be checked at least once every 12 months by law. But more challenging applications will require checks more frequently – even once every three months."


